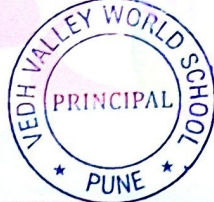
Dear Parents,

We encourage all PTA members to attend the draw for the selection of the Executive Committee.

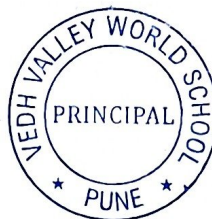
